1 Opening, welcome members and Acknowledgement of Country (Acting Chair)

- Housekeeping and summary of agenda

Safety, Security and technical considerations in the new buildings – project update (HV Staff, Project Team)

- Presented the floor plans/design of the new towers. The committee noted the final designs are coming together
- Activity on site has increased with site establishment and traffic changes.
- Internal fixtures, including kitchens and bathrooms, continue to be removed.
- A crane is due to be installed mid-year
- Ongoing removal of hazardous materials by accredited specialists.
- The committee discussed safety and technical aspects of the new buildings. including how safety has been built into the design.

Engagement Activity – Building a strong working relationship with community (Acting Chair)

Committee members were asked to engage with their neighbours and community to get their feedback on the following questions before the next meeting:

- How can Homes Victoria better engage with the community?
- How can Homes Victoria ensure community voices are heard in the planning process?

Action: The committee will discuss feedback at the next meeting and explore ways to include community voice in future high-rise redevelopment projects.
